On due evaluation of your marketing infrastructure and assessment of the  
technical capabilities of the persons available with your company, this office agrees to  
recognize your company as an approved operator for the purpose of marketing Auto  
LPG Dispensing through Auto LPG stations regulated under SMPV(U) Rules, 1981  
within the state of Gujarat.

This approval is issued subject to the under mentioned conditions:-

1. The first 5 ALDS sites shall be of company owned and company operated type.
2. Rating Certificate under Liquid Petroleum Gas (Regulation of use in Motor Vehicles) order, 2001 is periodically renewed and valid copy is submitted to this office regularly.
3. Only trained technical manpower, is deployed as Station Manager, Supervisor and Operators to run/operate any ALDS site.
4. Any change in the technical setup of the company is immediately intimated to this organization with suitable replacement of technical persons.

The approval shall be provisionally valid for a period of Five year i.e. upto 31/03/2018 during which time you will be permitted to set upto 50 numbers of Auto LPG stations for which proposal for prior approval may be forwarded.

The extension of the approval shall be considered after evaluation and assessment of your performance of the basis Auto LPG Stations run by your company in this period. Proper account of the Auto LPG procured and supplied to each site be maintained.

This organization reserve the right to withdraw this recognition, if the details furnished by you are at any time found to be incorrect or if the conduct of the company is marketing Auto LPG is found detrimental to public safety.


